## RESOLUTION OF THE VILLAGE BOARD OF THE VILLAGE OF TWIN LAKES DISALLOWING A CLAIM FOR DAMAGES AGAINST THE VILLAGE FILED ON BEHALF OF RICHARD THAYER

The Village Board of the Village of Twin Lakes, Kenosha County, Wisconsin, do resolve as follows:

WHEREAS, on November 8, 2023, the Village was served with a claim for damages ("Claim") on behalf of Richard Thayer ("Claimant"); and,

WHEREAS, the Village has been advised by its litigation counsel to deny the Claim.

NOW, THEREFORE, BE IT RESOLVED by the Village Board of the Village of Twin Lakes that:

- 1. The Claim is hereby disallowed in full; and,
- 2. The Village Clerk is directed to mail a copy of this Resolution as notice of disallowance to the Claimant, and to the Claimant's attorney, via certified mail, restricted delivery, return receipt requested; and,
- 3. Per Wis. Stat. 893.80 (1g), no action on the Claim may be brought after 6 months from the date of service of the notice of disallowance, and the notice of disallowance shall contain a statement to that effect.
