Subject: High Pressure System for 6577

Laura,

Attached are the two quotes for us to upgrade our Grass Rig 6577 with a new pump and some internal upgrades. The current pump on this vehicle is a 1993, has had several failures and we have had difficulty getting parts to repair it. To replace a similar pump style is around \$11,000. We want to upgrade the system to better prepare the situation we have with two full-time personnel in the station and the fact they can respond more rapidly to a fire with in the Village limits. I can do a presentation for the board if needed. This system fits what we are looking for with only 2 personnel showing up to a house fire quicker than an engine or our ladder truck. This system allows a more maneuverable hose line to apply high pressure droplets of water onto a fire from a safe distance.

We also want to add some items to this vehicle to help at emergency scenes to be able to communicate better and make an emergency scene operate as smooth as possible. We learned at the recent drowning that our radios around the lake don't work as well if on the portable radios, but if we use mobile radios we can communicate with dispatch, in coming units, and even units on scene more efficiently and safely.

I have money in the budget to purchase most of the radio equipment, but not to outfit the vehicle correctly. We also need to place an internal charging unit on this rig to help with the new pump and new equipment.
